ACTOR DEAL MEMO

THIS CONTRACT made by and between [NAME OF PRODUCTION COMPANY], a _____ corporation (hereinafter referred to as "Producer") and [NAME OF PERFORMER] (hereinafter referred to as "Performer"):

WHEREAS Producer intends to produce a photoplay the working title of which is " _____ " (the "Motion Picture"), which is intended for initial theatrical exhibition.

AND WHEREAS Producer wishes to retain the services of Performer in connection with the Motion Picture, and Performer wishes to provide such services, upon the terms and conditions herein contained.

1. Photoplay, Role, Salary and Guarantee

Producer hereby employs Performer to render services in the role of _____ (the "Role") in the Motion Picture at the salary of \$ _____ per day / per "studio week". (*Schedule B players must be paid additional overtime payment of four (4) hours at straight time rate for each overnight location Saturday.*) Performer accepts such employment upon the terms and conditions set out herein. Producer guarantees that the period of Performer's employment hereunder will be not less than _____ days. Performer shall be paid pro rata for each additional day beyond the guarantee period that Performer's services are required by Producer.

2. Term

The term of employment hereunder shall begin on or about _____ (the "Start Date") and continue until _____ or such later date as is necessary to complete the photography and recording of the Role. Producer reserves the right to discharge Performer at any time.
