### 4. CONDITIONS PRECEDENT

4.1 The Purchaser's obligations to complete the transactions contemplated herein are subject to the fulfillment of each of the following conditions on or before 90 days after acceptance of this Offer to Purchase:

The aforesaid conditions are inserted for the sole and exclusive benefit of the Purchaser and may be waived in writing by the Purchaser at any time prior to the expiration of the periods above described. In the event that the aforesaid conditions have not been waived by the Purchaser by notice in writing to the Vendor prior to the dates described in Clause 4.1 hereof, then the agreement arising from the acceptance of this Offer shall be automatically

terminated. In the event of such termination, neither party shall have any further rights or obligations hereunder. Should the Purchaser waive the conditions within the time frame described, the agreement shall become a binding agreement of purchase and sale, closing as described in Clause 2.1, and the date of said notice of waiver of conditions, shall be accepted as the date of removal of conditions.
