THIS AGREEMENT WITNESSES THAT, in consideration of the mutual covenants set forth in this Agreement, the parties hereby agree as follows:

## 1. Wedding Date and Location

## 2. Photo / Video Services

Photographer agrees to provide the services set out in the attached Exhibit "A" - "Photo / Video Services".

### 3. Package Price

The package price for The Photo / Video Services and one (1) copy of all photographic or videographic images and materials created by Photographer for Customer (collectively the "Materials") is \$\_\_\_\_\_, to be paid as follows:

- (a) non-refundable deposit of \$\_\_\_\_\_ to book The Photo / Video Services for the Wedding Date;
- (b) balance of \$\_\_\_\_\_ payable not later than three (3) days prior to the Wedding Date.

Any additional hours or cameras will be billed out at the rates set out in Exhibit "B" – Rates for Services.

### 4. Deposit

A \$\_\_\_\_\_ non-refundable deposit ("Deposit") is required to secure The Photo / Video Services for the Wedding Date. If the Wedding Date is changed or cancelled, the Deposit is forfeited. An additional Deposit will be required to secure a new date, if available. If the Deposit is paid by check and the check is returned by the bank for any reason, this Agreement shall be deemed void.

### 5. Timely Payment

Time is of the essence for receipt of payment hereunder. No rights to the Materials are granted to Customer until timely payment is made in full. In the event Customer fails to pay the amounts due by the date(s) on which the same are due, Photographer has the right to withhold Materials or to suspend any further Services performed on behalf of Customer until payment in full is received, plus accrued late charges of \_\_\_\_\_ percent (\_\_\_\_%) per month.

### 6. Changes and Cancellations

- (a) If the date, time and/or location of the Wedding are changed after the execution of this Agreement, Photographer is not obligated to honor such change. Customer must notify Photographer of such change in writing immediately upon becoming aware of same, and Photographer shall use best efforts to make a camera person available for the new date, time and/or location.
- (b) If the Wedding is cancelled due to serious injury, serious illness or death to or of the groom, bride or an immediate family member, this Agreement shall become null and void. "Serious injury" or "serious illness" is defined as an injury or illness which requires hospitalization or which renders the person physically unable to attend the Wedding. In such event, Photographer will return all deposits paid by Customer, and will not charge for time or materials costs incurred while preparing for the Wedding shoot. Likewise, serious injury, serious illness or death of or to an employee of Photographer or their immediate family will cause this Agreement to become null and void.
- (c) In the case of serious injury, serious illness or death, as set out in sub-paragraph (b) above, Customer or Photographer (as the case may be) must, as soon as reasonably possible, produce a notice in writing of such injury, illness or death, stating the relationship of the patient / victim to Customer or Photographer (as the case may be), and the notice must be signed by an attending physician, charge nurse or funeral director. A copy of the death certificate will suffice in case of death.
- (d) For purposes of this Section, "immediate family" will include spouses, parents, stepparents, grandparents, siblings, children, stepchildren, grandchildren, employees of Photographer, and the bride or groom.

### 7. Customer's Responsibilities

Customer shall be responsible for obtaining or providing the following:

- (a) Permission from the church, synagogue, chapel or other officials to photograph / film the ceremony. The Deposit is not refundable if such officials prevent photographing or filming;
